4. STUDENT REPORTS

6.01 Student Report – Jonathan Kirk and Angelica Rodriguez

Information

Board representative Jonathan Kirk shared club and sports information with the board. Chairman Dennis Carlton thanked him for his report.

5. GOOD NEWS Information

The following individuals shared the good news that is happening within the school district:

• WAVA-Stride Executive Director Susan Boyer was excited to share that one of their WAVA students has been featured in the "One Leg Up on Adapting" podcast, where they discuss the impact WAVA online has had on his education with his challenges as a student with dyslexia and his athletic career as a pro disc golfer.

- East Elementary Principal Lee Ann Schrock shared that their goal for student growth this year was a 10% improvement, and they are excited to share that with January STAR testing, students have made significantly larger growth in reading and math. Both staff and student dedication to learning is paying off, and everyone feels very successful. The teamwork of North Elementary and East Elementary for student learning is beginning to show great student improvement. The fifth-grade Math is Cool team will compete this Friday in Wenatchee, and our third and fourth-grade teams will compete in Wenatchee on March 23rd. The recent partnership with NCESD and the Department of Transportation for bike safety not only provided training on bike riding skills and safety for our students but due to extra dollars available in the grant, ALL fifth-grade students will be receiving a one-time award of a new mountain bike & helmet to take home. The program also donated six trikes for our life skills classroom.
- Secondary Dean of Students Audrey Hunt shared that the Middle School Math is Cool team placed sixth in Wenatchee on February 2nd and was invited to the Math is Cool Masters, which is a competition that typically presents more challenging problems than the regional competition. March Madness, an on-time/attendance student competition bracket, is in full swing. Club Shred has made five trips to the Loup Loup Ski Bowl, with an increase of ten student participants this year. Our local 2 Scoops business continues to support our students through the Principal 100 Club, which recognizes good student behavior. Administrative Intern Leilani Beck shared data after the third set of STAR testing. They have seen a significant increase in reading and math scores in students at or above grade level. They are seeing significant growth, which is very exciting for our staff and students.
- High School Principal David Kirk shared that our boy and girl wrestlers represented Omak well at the State Tournament, with two state champions and several finishing in the top three. Our Theatre students are presenting "Seussical" on March 1, 2, 8, and 9 at 7:00 p.m. Omak is again partnering with the Okanogan School District for Junior Business Week next Monday through Thursday at the Agriplex. On Friday, March 8th, students interested in the medical field are invited to participate in "Scrubs Camp" at Wenatchee Valley College. We are beginning to register students for 2024-25 courses. Spring Sports started on Monday and thanks to good weather, all teams can practice outside. Students will participate in WIDA testing for English Language Learners and NAEP testing, in which random students are selected nationally every two years.
- Assistant Principal Chris Miller shared that their building is also testing students and should have testing data available next month. North hosted a NED (Never give up, Encourage others, Do your best) assembly motivating and engaging students with yo-yos. Students are cracking the books enthusiastically, preparing for the Mason's reading challenge-bike giveaway. North Elementary's book fair is scheduled for March 11th 15th, with a family night on March 14th from 5:00 7:00 p.m. focusing on literacy. First graders will have their first concert on March 19th at 1:00 p.m. We currently have six students who have not missed any school days this year.

For our salmon update, 73 eggs have hatched, and the students are looking forward to the release celebration tentatively scheduled for April 10th.

- Executive Director of Finance Scott Haeberle shared that the district received a \$172,000 grant to upgrade the high school's fire and security system. The district will work with the State Auditor for approximately two months, and he will be scheduling appointments with Program Directors.
- Executive Director of Teaching and Learning Jill Timm shared that the WaKIDS Assessment shows that overall, students entering kindergarten are more prepared than ever before, with a state percentage of 52%. Omak kindergartners are significantly higher, with 61.3% showing readiness in all six categories. This shows that our preschool and early learning partnerships are working.
- Superintendent Michael Porter thanked everyone for supporting our schools. It is a great feeling to pass our EP&O Levy at 61.98%. Washington State recognizes two significant groups of employees who bring support and value to our community and students. We celebrate Washington State Retirees March 18th—24th and Education Support Professionals March 11th—15th. Thank you for being so dedicated to our students.
